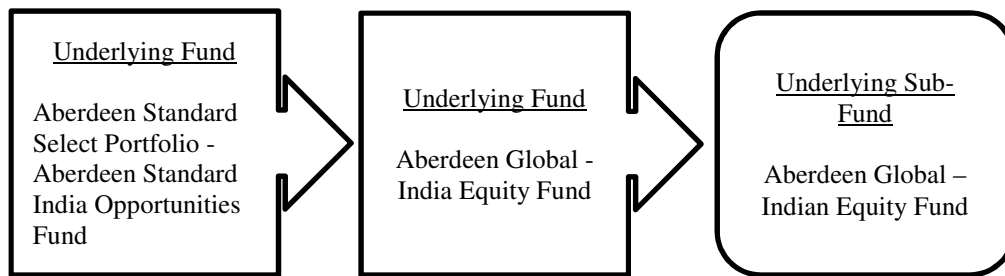

<b>Investment Strategy</b>	
<p>The Underlying Fund will invest all or substantially all of its assets in the Aberdeen Global – Indian Equity Fund. This Underlying Sub-Fund invests at least two-thirds of its assets in equities and equity-related securities of companies with their registered office in India; and/or, of companies which have the preponderance of their business activities in India; and/or, of holding companies that have the preponderance of their assets in companies with their registered office in India.</p> <p>Investors should note that for efficient portfolio management purposes, a wholly-owned Mauritian subsidiary is utilised by Aberdeen Global to hold all the investments of the Underlying Sub-Fund.</p>	<p>Refer to "Investment Objectives and Focus of the Sub-Funds" and "Investment strategy/policy" sections 9 and 11 of the Underlying Fund's Prospectus for further information.</p>

<b>Market and Credit Risks</b>	
<p><b>You are exposed to the market risk.</b></p> <p>Prices of the securities owned by the Underlying Sub-Fund may rise or fall in response to changes in economic conditions, political conditions, interest rates, and market sentiment. These may cause the price of units of the Underlying Fund to go up or down.</p>	
<b>Liquidity Risks</b>	
<p><b>You are exposed to liquidity risk.</b></p> <p>The securities that the Underlying Fund owns may at times lack liquidity thereby affecting their value or ease of disposal. The Manager may, subject to the trust deed, limit the total number of units which unit holders may dispose if the total number of units to be disposed on any Dealing Day exceeds 10%.</p>	
<b>Product-Specific Risks</b>	
<p><b>You are exposed to currency risk.</b></p> <p>The assets and income of the Underlying Fund will be substantially denominated in currencies other than the Singapore dollar. Currency fluctuations between foreign currencies and the Singapore dollar may affect the income and valuation of the assets of the Underlying Fund in ways unrelated to business performance.</p> <p><b>You may be exposed to regulatory risk.</b></p> <p>The investment objectives and parameters of the Underlying Sub-Fund are restricted by legislative and regulatory guidelines. There may be a risk that legislative or regulatory changes may make it less likely for the Underlying Fund to achieve its objectives.</p> <p><b>You are exposed to emerging markets risk.</b></p> <p>Exposure to emerging markets increases potential volatility in your portfolio as the legal,</p>	

judicial and regulatory infrastructure in emerging markets is still developing and this may create uncertainty for investors.

**You are exposed to single country risk.**

The Underlying Fund invests in a single country market, making it more concentrated and potentially more volatile than if it invested across regional or global markets.

Payable directly by you

There is currently no Switching Fee for fund switching. Sales and/or Surrender Charges may be applicable as described in the relevant Product Summary. However, Aviva reserves the right to review and amend the Fees and Charges.

Payable by the Underlying Fund from invested proceeds

The Underlying Fund will pay the following fees and charges to the Manager and Trustee:

<b>Management Fee</b>	1.5% p.a. (maximum 2.5% p.a.)
<b>Trustee Fee</b>	Maximum 0.15% p.a., subject to a minimum of S\$10,000 p.a.

Other fees and charges, including inter alia the Sub-Registrar's fees, may each amount to or exceed 0.10% per annum of the NAV of the Underlying Fund, depending on the proportion that each fee or charge bears to the NAV of the Underlying Fund.

**HOW OFTEN ARE VALUATIONS AVAILABLE?**

**HOW CAN YOU EXIT FROM THIS INVESTMENT AND WHAT ARE THE RISKS AND COSTS IN DOING SO?**

- You can exit the ILP Sub-Fund by submitting a request for withdrawal or fund switching (i.e. switches) to Aviva Ltd.
- If your Policy is newly inceptioned, you may cancel the Policy by giving us written notice of cancellation provided that such notice of cancellation is received by Aviva Ltd at its Registered Office within the free-look period, which is fourteen (14) days from the date on which you receive the Policy.
  - Upon cancellation of the Policy, Aviva Ltd will refund the premiums you paid (without interest) after deducting the expenses incurred in issuing the Policy. The refund will be made after we receive the original Policy for cancellation.
  - If there has been a decline in the market value, we will deduct the amount necessary to reflect the change in market value. If there has been an increase in the market value following the date Aviva Ltd accepts your request to cancel the Policy, we will not pay you for such increase or any gain.
- For subsequent withdrawal/surrender or fund switching, transaction requests will need to be received and accepted by Aviva Ltd:
  - (a) before 12 noon (Singapore time) on a Business Day will be processed according to the Unit Prices of the relevant Funds and the exchange rates (if applicable) prevailing on the next appropriate Fund Valuation Date following the day Aviva Ltd has accepted the request.
  - (b) after 12 noon (Singapore time) on a Business Day or on a non-business day will be considered as if received before 12 noon (Singapore time) on the following business day.
- The ILP Sub-Fund will have a single "dealing" price used for all switches and withdrawals/surrenders. There is no bid/offer spread.

- All ILP Sub-Funds will be priced based on the frequency of the fund manager’s pricing policy. As Units are cancelled using a forward price, the unit price for all switching and withdrawal of units will not be available at the time of receiving your application.
